Tuition fee rates for students and external students in the academic year 2018/2019

1. The tuition fee rate for 1 ECTS credit point of a course (excluding supervision of a final thesis) for first and second level students in part-time studies and students in self-financed study places enrolled in the academic year 2017/2018 or later.

2. Full-time first and second level students enrolled in the academic year 2017/2018 or later and studying in study programmes taught in Estonian or English free of charge, including at a student place funded by tuition fee waiver scholarship, who fail to complete the cumulative semester load subject to completion under the study programme, shall pay the tuition fee rate 40 euros for 1 ECTS credit point for the credit points by which they fall short of the nominal load, excluding the students studying in the study programmes of Public Sector Innovation and e-Governance and European Architecture. [entry into force 01.09.2018].

3. The tuition fee rate for 1 ECTS credit point of a course (excluding supervision of a final thesis) for first and second level students in part-time studies and students in self-financed study places enrolled in curricula taught in Estonian and Russian before the academic year 2017/2018.

5. Students from outside the European Union and students studying European Architecture shall pay for the credit points before matriculation for two semesters provided that the student declares courses in the amount of at least 30 ECTS credit points. The fee for ECTS credit points shall be calculated based on the established fee rates.

⁵¹ Full-time students, who have been matriculated in the academic years from 2013/2014 to 2016/2017 (hereinafter referred to as "previous period") in curricula of the School of Business and Governance (excluding Bachelor's study in Logistics) taught in Estonian and who fail to complete the semester load subject to completion under the curriculum, shall pay for the volume of study by which they fall short of

the nominal load in accordance with the credit point price set out for the year of admission to the university. [entry into force 19.04.2018]

6. Students studying Cyber Security Engineering shall pay a semester fee in the amount of 1200 euros regardless of the amount of declared credit points.

7. Tuition fee rates to be paid by students for final thesis and final examinations

7.1 The credit point fee for a final thesis and a Bachelor's examination is 50% of the credit point fee of the relevant curriculum (excluding the students and external students studying European Architecture).

7.2 The credit point fee for the final examinations in the curricula of TTÜ Estonian Maritime Academy is 50% of the credit point fee at the TTÜ Estonian Maritime Academy.

8. Fee for reviewing the admission documents

8.1 The one-time fee for reviewing the admission documents for foreign students is 100 euros.

9. Fees to be paid by external students

9.1 The following fees shall be applied to external students, who have completed their final thesis without a supervisor from TTÜ or, as students, under supervision of a member of TTÜ teaching or research staff, or who take the final examination:

9.1.1 Bachelor's thesis and examination 100 euros

9.1.2 final thesis and examination in professional higher education 160 euros;

9.1.3 Master's thesis and examination and final thesis and examination in engineering studies 300 euros

9.1.4 Doctoral thesis 0 euros

9.2 The fee applied to an external student, who was supervised by a member of TTÜ teaching or research staff and who has not paid for supervision, is the same as the fee applied for supervision of the final thesis of a student enrolled in the same academic year and studying at the same level of higher education.

9.3 The final examination fee applied to external students in the curricula of the TTÜ Estonian Maritime Academy is the same as the final examination fee applied to students enrolled in these curricula in the corresponding academic year.

10. Payment of tuition fees and arrears [entry into force 19.04.2018]

10.1 Full-time students in curricula taught in Estonian, who fail to complete the semester load subject to completion under the curriculum, shall pay tuition fee for the volume of study by which they fall short of the nominal load in accordance with the Academic Policies. Part-time students and students in self-financed study places in curricula taught in Estonian shall pay tuition fee in accordance with the contract for reimbursement of tuition costs entered into between TTÜ and the student. The standard terms of the contract for reimbursement of tuition costs shall be approved by the Rector.

10.2 A student shall, once a semester, receive an invoice issued based on the Academic Policies or contract for reimbursement of tuition costs (payment of tuition fee). The deadline for payment of the invoice is ten calendar days from the submission of the invoice.

10.3 In case of a delay in the payment of the tuition fee, fine for delay shall be charged from the student in the amount of 0.06% of the amount due for each calendar day the payment is delayed.

10.4 In the case the invoice specified in clause 10.2 is not paid on time, the deadline for payment of the invoice submitted for tuition shall be extended for three calendar months based on the student's application.

10.5 Any debt claims against a student arising from overdue tuition fee shall be transferred, in part or in full, to a third party or recovered through court.

11. A fee is charged for studying subjects not included in the curricula. The Rector has the right to allow a student to study these subjects free of charge.
